DUES PAYMENTS WILL NOT BE ACCEPTED AT THE POOL

Forms for every residence do not automatically renew yearly. They must be filled out for each pool season.

For rental properties, a letter from the lot owner granting permission for their tenants to use the pool must accompany this form. Pool Passes are issued to either the lot owner or the tenants. This decision is fully at the discretion of the lot owner.

Association Dues **MUST** be current for passes to be issued. Dues payments will not be accepted at the pool at any time. Lifeguards do not have access to dues information.

Each lot will receive one (1) Guest Pass for repeated use the entire pool season. It is limited to bringing in only one (1) guest per day. Additional guests must pay a \$5 fee per guest.

VERIFICATION WILL BE CHECKED FOR EACH RESIDENCE.

Proof of residency **MUST** be provided with this form. Proof of Residence can be a copy of a Virginia Driver's License or copy of a recent Utility Bill. Please send in a copy of Proof of Residence for every adult member that lives at the residence that you are requesting passes for. The residential address **MUST** match the address on file. No exceptions.

Any child residing at your property that is or will be 18 during the swim season will be required to provide proof of residency.

Passes will not be made until each lot meets the above requirements are fully met.
